#### 8 Old Business:

Questions regarding bonding and liability insurance will be addressed at a meeting with the insurance agent and the Fire Chief and Board Secretary. Our Insurance agent will come and explain the current coverage which includes bonding and liability. We just need to identify specific staff and board positions and confirm coverage amounts for both liability of theft and administrative coverage for board members..

Bank signatories have been made at the Fireboard's bank. Roger, Ann and Josh are able to sign checks.

Grant Update: No information currently available.

10. Firefighter Attraction and Retention Update

The Breakfast gatherings each month are going well. Board is interested in finding community sponsors to support the food for this important relationship building event. Board members and fire fighters have been funding the events. Board members will talk with community businesses and residents to see if they are interested in supporting one of the monthly events.

- 11. Building Update: Overhead door spring is still broken. Damaged OHD—the plan is to continue to find a way to remediate situation. Chris offered to work with Safe Build to find a solution to resolve the issue.
- 12. Galesburg City Counsel Briefing Update: Brief update by Roger Frazee.
- 13. Legal Update: A list of questions was reviewed with the attorney prior to the meeting by the secretary due to another commitment for our attorney. The attorney reviewed the steps necessary for cost recovery which requires each

municipality to have an ordinance. Both Galesburg and Charleston do have an ordinance in place. Copies were sent to the attorney for his review to ensure current language for both municipalities for proper enforcement purposes.

The Fireboard does have bonding and liability insurance and will confirm and update as needed on May 24<sup>th</sup> with our insurance agent.

Continue to investigate standards and practices with other fire departments regarding yearly business fire inspections. Working on performance review standards and implementation with the attorney.

Suggestions were discussed regarding job descriptions for both the fire chief and assistant fire chief position. Copies of other job descriptions will be available at the next meeting to initiate this process.

Have contacted our auditor to specify our bylaws as requested in pending new contract.

Pride Care has requested permission to stage a staffed ambulance at the fire station. They are requesting access to the Fire Station meeting room and City Hall bathrooms.
